Advisory Committee’s Purpose:

The Promotor(a) or Community Health Worker Training and Certification Advisory Committee (CHWTCAC) is charged with the following:

- Advise DSHS and the Health and Human Services Commission (HHSC) on the implementation of standards, guidelines, and requirements adopted under the Health and Safety Code, Chapter 48, relating to the training and regulation of persons working as promotores or community health workers;
- Advise DSHS on matters related to the employment and funding of promotores and community health workers;
- Provide recommendations to DSHS for a sustainable program for promotores and community health workers consistent with the purposes of Health and Safety Code, Chapter 48, Subchapter C;
- Review applications from training programs/sponsoring organizations, and recommend certification to DSHS if program requirements are met; and,
- Carry out any other tasks given to the committee by the Commissioner or Executive Commissioner.

CHWTCAC members serve as the voice of promotores or community health workers in their communities and have a key role in assisting DSHS and HHSC as the community health worker training and certification process in Texas continues to evolve.

Advisory Committee Activities

Advisory Committee members participated in the activities listed below in calendar year 2011.

Program Rules

- *Advise on program rules under the Health and Safety Code, Chapter 48, relating to the training and regulation of persons working as promotores or community health workers.*
 - Committee members provided initial feedback on proposed changes to the Promotor(a) or Community Health Worker Training and Certification Program rules (25 Texas Administrative Code §§146.1-146.12) in June 2011.
 - The committee had the opportunity to review proposed rules published in the Texas Register on October 14, 2011 for public comment.

Communication and Outreach

- *Assist in the development of the CHWTCAC Annual Report.*
 - Committee members provided input regarding activities undertaken in 2011 and planned activities for 2012.
- *Increase communication with community health workers.*
 - Committee members participated in, and shared information with, local or regional networks of community health workers.
 - Two committee members were appointed to the National Steering Committee for Promotores with one being designated as the chair of the National Steering Committee. Their work with the National Steering Committee resulted in a White House letter recognizing the valuable role of promotores in providing education on wellness and connecting individuals and families to vital health and social services.
- *Identify and explore additional opportunities for outreach and information regarding the Promotor(a) or Community Health Worker Training and Certification Program and the work of the CHWTCAC.*
 - Committee members participated in the nomination and application review process for vacancies on the Advisory Committee:
 - Public member appointment (to fill remainder of term)
 - Community health worker member vacancies (two terms expiring December 31, 2011)
 - Professional member appointment (one term expiring December 31, 2011)
 - One committee member presented information at the El Paso Community Health Worker Workforce Strategic Planning Event.

Training/Workforce Development

- *Make recommendations to the department concerning qualifying training programs/ sponsoring organizations.*
 - The committee reviewed applications for training program/sponsoring organization certification and made recommendations to DSHS for three additional community health worker certification and continuing education training programs, three additional community health worker continuing education training programs, and one additional instructor continuing education training program, including:
 - El Centro College (Dallas - Community health worker certification and continuing education)

- Texas Area Health Education Center (AHEC) East – Northeast Region (formerly Lake Country AHEC - Tyler - Community health worker certification and continuing education)
- University of Texas School of Public Health (Houston and satellite sites - Community health worker certification and continuing education and instructor continuing education)
- DSHS Health Service Region 1 (Lubbock - Community health worker continuing education)
- South Texas Promotor(a) Association (Edinburg - Community health worker continuing education)
- National Center for Farmworkers Health (Buda - Community health worker continuing education)
- *Increase access to community health worker certification training and continuing education.*
 - Committee members affiliated with DSHS approved training programs conducted workshops for community health workers and community organizations as part of the DSHS Healthy Texas Babies Initiative to reduce infant mortality and pre-term birth.
 - Committee members affiliated with DSHS approved training programs also organized and conducted large region-wide or statewide conferences for community health workers:
 - Bi-National Conference - October 7, 2011 - Edinburg, Texas
 - Annual Community Health Worker Conference: “Promotora Navigation - Build On That” - October 17-19, 2011 - San Antonio, Texas
 - “Expanding the Role of Promotores/Community Health Workers in Health Reform” - November 10-11, 2011 - Austin, Texas
 - Committee members participated in a joint project with DSHS staff to provide information to DSHS approved training programs to assist programs in meeting continuing education needs in their local areas and across the state.
 - A memo was sent jointly from DSHS staff and Advisory Committee members to training programs and included additional data related to certified community health workers, such as current total number of certified community health workers, increase in the number of certified community health workers in 2010 and anticipated increase in 2011, as well as location, preferred language, and expiration and renewal data.
 - A Committee member also provided input in the initial development of a process to gather updated information on all DSHS-approved curricula to promote communication with, and between, training programs.
 - Complete pilot project of the community health worker evaluation tool and recommend core elements toward evaluation of 160-hour training programs.
 - Committee members affiliated with a training program implemented a pilot study to evaluate a promotor(a) lead outreach and education program.

Certification/Employment Opportunities

- *Promote employment opportunities for community health workers and explore opportunities for sustainable funding of community health worker services.*
 - Committee members provided input in the development and implementation of the Community Health Worker Study required under HB 2610, 82nd Legislature, Regular Session – 2011. An update on the Community Health Worker Study is set as a standing agenda item for CHWTCAC meetings beginning July 2011 through completion of the study.



SECTION II: CERTIFICATION INFORMATION

Community health workers are eligible to be certified in Texas by completing DSHS-certified training of at least 160 hours or based on experience through providing at least 1,000 hours of community health work services in the most recent six years.

Total Number of Certified Community Health Workers

- As of December 31, 2011, there were 1,583 certified community health workers, an increase of 37% as compared to 1,153 certified community health workers at the end of 2010.



Community Health Workers Newly Certified in 2011

- A total of 554 community health workers were newly certified during 2011.
- This represents a slight decrease (5%) from 2010 when a total of 585 community health workers received their initial certification.

Community Health Worker Certification Training Graduates 2011

- Over 280 individuals graduated from a DSHS approved community health worker certification training program of at least 160 hours in 2011.
 - The number of graduates decreased as compared with 2010 when 387 individuals graduated from a DSHS approved community health worker certification training program of at least 160 hours. The number of graduates in 2011 continues to be significantly higher than in years prior to 2010. In previous years, approximately 80 to 123 individuals graduated annually from a community health worker certification training program.
 - **Note:** Some graduates from DSHS approved training programs do not apply for certification; therefore, the number of graduates may not reflect the number that applied for certification based on training.

Community Health Worker Certification Based on Completion of Training or Experience

- Approximately 41% of community health workers newly certified in 2011 were certified based on completion of training.
 - The percentage of certification based on training decreased as compared to 2010 when 63% of newly certified community health workers were certified based on completion of training.
- Approximately 59% of newly certified community health workers in 2011 were certified based on experience.

Instructors are eligible to be certified in Texas by completing DSHS-certified instructor training of at least 160 hours or based on experience with at least 1,000 hours of experience training individuals who provide community health work services, including promotores, community health workers, and other health care paraprofessionals and professionals.

Total Number of Certified Instructors

- As of December 31, 2011, there were 115 certified instructors, an increase of 25% as compared to 92 certified instructors at the end of 2010.

Instructors Newly Certified in 2011

- A total of 29 instructors were newly certified during 2011.
This represents a decrease (5%) from 2010 when a total of 53 instructors received their initial certification.

Instructor Certification Training Graduates 2011

- One DSHS approved instructor training program (Día de la Mujer Latina) provided instructor certification training in 2011 via distance learning, providing access to training for individuals in El Paso, Harris, Tarrant, and Travis counties.
- Ten individuals graduated from a DSHS approved instructor certification training program of at least 160 hours in 2011.
 - This represents a decrease in instructor graduates as compared with 2010 when 31 individuals graduated from a DSHS approved instructor certification training program. The number of instructor graduates in 2011 continues to be higher than in years prior to 2010 when only 1-5 instructors graduated from a DSHS approved instructor certification training program annually.

Certification Based on Completion of Training


- About 28% of newly certified instructors in 2011 were certified based on completion of training, while 72% newly certified instructors in 2011 were certified based on experience.

SECTION III: RENEWAL INFORMATION

Community Health Worker Renewals

Community health workers must complete at least 20 hours of continuing education every two years to renew their certificate, including at least ten (10) DSHS-certified contact hours.

- The percentage of community health workers renewing their certification has continued to increase over several years.
- In 2011, 60% of community health workers renewed their certification before expiration, as compared to 53% in 2010. The percentage of renewal has increased over the past three years.



- Note: An additional 10% renewed their certification in 2011 following expiration.

Community Health Worker Expired Certificates

Community health workers may renew a certificate that has been expired for less than one year by submitting a renewal application documenting the completion of the required continuing education.

Community health workers may request to regain certification by submitting a new initial application when a certificate has been expired for a year or more.

- Certification expired and was not renewed in 2011 for a total of 115 community health workers.
- Many of the certifications that expired and were not renewed in 2011 were for community health workers first certified in 2009 (about 59% of total 2011 expired certificates).
- Approximately half of the certificates that expired in 2011 occurred in the last four months of 2011, therefore, it is anticipated that some of these certificates may be renewed in 2012.

Instructor Renewals

Instructors must complete at least 20 hours of continuing education every two years to renew their certificate, including at least ten certified hours of continuing education from participation in a DSHS approved instructor training program. Instructors also have the option of combining five DSHS-certified hours of instructor continuing education and up to five hours of continuing education completed to renew a Texas license or certification in another health profession or credit for instruction delivered to promotores, community health workers or instructors in DSHS-certified training to meet the required ten certified hours.

- In 2011, 73% of instructors renewed their certification before expiration. One instructor renewed their certification in 2011 following expiration, therefore a total of 78% of instructors renewed their instructor certificates in 2011.

Instructor Expired Certificates

Instructors may renew a certificate that has been expired for less than one year by submitting a renewal application documenting the completion of the required continuing education.


Instructors may request to regain certification by submitting a new initial application when a certificate has been expired for a year or more.

- Five instructors did not renew their certification in 2011. One instructor retired; however, it is not known why the remaining instructors did not renew their certificates. Several of these expirations occurred in the last three months of 2011; therefore, it is possible that some may seek renewal in 2012.

Counties with At Least One Certified Community Health Worker


- The number of Texas counties with at least one certified community health worker grew from 82 counties at the end of 2010 to 101 counties as of December 31, 2011, an increase of 23%.

Continuing Education for Community Health Workers

- DSHS approved training programs/sponsoring organizations provided approximately 160 continuing education opportunities for community health workers, offering a total of over 600 DSHS-certified contact hours, including face-to-face events and distance learning continuing education.
- Training occurred in 15 counties and through distance learning.
- The total number of participants was over 4,000 due to continuing education provided at several larger events/conferences; however, this is not an unduplicated count. Community health workers may have accessed a number of continuing education events; therefore, the unduplicated count would be lower. Not all participants attending continuing education events are certified community health workers.

- Four instructor continuing education opportunities occurred through distance learning and two were on site events.


