

You must notify a local mental health authority (LMHA) when a PASRR Evaluation is required

- Every person being considered for admission to a Medicaid-certified nursing home must have a Level I Screening performed by the referring medical professional or entity.
- If the Level I Screening indicates that a person might have mental illness, an intellectual disability, or a related condition, a completed and submitted PASRR Evaluation is required.
- If a PASRR Evaluation is required, then a LMHA must be notified.
- After being contacted by the referring medical professional or entity, the LMHA has 72 hours to complete the PASRR Evaluation.

Steps to find a local mental health authority (LMHA) using the DSHS website

- 1 In your web browser enter:
www.dshs.state.tx.us/mhservices-search
- 2 Select a search method (County, City or Zip Code) by clicking the button to the right of your selection.
- 3 If you select “Search by County,” use the drop-down box to find and select your county. If searching by “City” or “Zip Code,” you must enter the city name or zip code in the box provided.
- 4 Click the “Search (Buscar)” button.
- 5 The name of the LMHA will appear below the search button, along with contact information and a link to the web page for that LMHA.

Helpful tips

- Links are underlined. Clicking on a link will take you to another page with additional information on that subject.
- You must use the “Search” button instead of the Enter or Return key.
