

Michael Scott has active pulmonary TB and now a contact investigation must be conducted.



#### **Reminder:**

- An initial interview for suspected or confirmed TB should be conducted within three working days of a patient being reported to the TB program.
- Patients who are AFB sputum smear positive and/or have chest imaging revealing cavitation must have the second interview seven days after the initial interview






