

NEDSS Jurisdiction List for Tuberculosis Users

The NEDSS database contains a list of health department jurisdictions that provide services for multiple notifiable conditions across the state. Not all health department jurisdictions listed in NEDSS provide tuberculosis (TB) services. A DSHS Public Health Region (PHR) or another local health department (LHD) may be responsible for monitoring and reporting TB condition events for these non-TB jurisdictions.
