1061-11-0150- Ms. Corley made a motion to table the complaint. The motion was seconded by Dr. Buckner and passed.




1061-13-0001- Dr. Bucker made a motion to close the complaint with no violation. The motion was seconded by Mr. Christopherson and passed.
