





Online medical director course offered to Texas personnel

Critical Illness and Trauma Foundation is now offering a web-based DSHS approved course for medical directors and interested EMS providers. This course is an entry level orientation for medical directors covering the essentials for emergency medical services (EMS) oversight and direction. It meets the requirements of Texas Administrative Code Title 22, §197.3.

The Medical Directors Online Course is available free for Texas personnel September 1, 2014 – August 31, 2015. You will receive a certificate of completion from the National Association of EMS Physicians (NAEMSP) at the end of the course. These materials were adapted from the National Highway Traffic Safety Administration’s (NHTSA) *Guide for Preparing Medical Directors* developed originally by the National Association of EMS Physicians (NAEMSP) and the American College of Emergency Physicians (ACEP).

This web-based program was produced by the Critical Illness and Trauma Foundation in collaboration with NAEMSP, the National Association of State EMS Officials (NASEMSO), Montana State University—Burns Technology Center and Oolite Media.

DSHS initial administrator-of-record course offered at Texas EMS Conference

DSHS will be presenting an initial administrator-of-record course during the preconference sessions of the Texas EMS Conference in November. The course is available to anyone interested in becoming administrator-of-record (AOR) and fulfills the new legislative requirement outlined in Senate Bill 8 for AORs to complete an initial education course in EMS administration. This course will include current information on Texas EMS laws and rules, dispatch, billing, medical accountability and quality improvement in the EMS system. The two-day course is offered November 22-23 at the Fort Worth Convention Center. Early registration pricing is \$325, after October 15 the rate is \$400.

FY15 Uncompensated Trauma Care (UCC) Funding Application

The Texas Department of State Health Services (DSHS), Office of EMS and Trauma Systems Coordination (OEMS/TS) is pleased to announce that the application needed to apply for the fiscal year (FY) 2015 Designated Trauma Facilities and Emergency Medical Services (DTF/EMS) Account - Hospital Allocation will be available October 15, 2014 and accessible on our website www.dshs.state.tx.us/emstraumasystems/.

The trauma care funding program enacted by House Bill 3588, 78th Texas Legislature, stipulates that 96% of the funds accumulated in the Designated Trauma Facilities and Emergency Medical Services (DTF/EMS) Account (3588 monies) be distributed to eligible Texas hospitals to reimburse a portion of their uncompensated trauma care. To be eligible for the DTF/EMS Account-Hospital Allocation, a hospital must be a designated trauma facility by the application due date or meet "in active pursuit of trauma designation" requirements by the application due date. The application must be emailed per instructions in the application no later than January 30, 2015.

"In active pursuit" requirements:

- Submit a letter of intent to designate as a trauma facility
- Submit a "timely and sufficient" trauma designation application;
- Submit evidence of data submitted to the State EMS/Trauma Registry;
- Submit evidence of participation in the appropriate Regional Advisory Council; and
- Provide evidence that a hospital trauma performance improvement committee has been developed.

Funds are distributed in the following manner:

- Fifteen percent of the total amount of funds available for the Hospital Allocation will be divided equally among all eligible applicants.
- The remaining 85% of the Hospital Allocation funds will be distributed to eligible hospitals based on the percentage of uncompensated trauma care a hospital provides in relation to the total uncompensated care provided by all the eligible hospitals that apply for the Hospital Allocation.

What is MUCC?

The Federal Interagency Committee on Emergency Medical Services (FICEMS) has statutory authority to identify state and local emergency medical services (EMS) and 9-1-1 needs, to recommend new or expanded programs and to identify the ways in which federal agencies can streamline their processes for support of EMS.

At a December 19, 2011, meeting of the Federal Interagency Committee on Emergency Medical Services (FICEMS) the FICEMS' Preparedness Committee presented a concept paper for FICEMS consideration on the national implementation of the **Model Uniform Core Criteria (MUCC)** for mass casualty triage. The FICEMS' Preparedness Committee was subsequently directed to develop a national MUCC implementation strategy for consideration by the FICEMS with input from the National EMS Advisory Council (NEMSAC).

FICEMS has adopted the following position statement:

The FICEMS recommends that state and local Emergency Medical Services (EMS) systems improve their mass casualty incident triage capabilities through adoption of triage protocols and systems that are based on the Model Uniform Core Criteria. Federal resources may be used to support development of capabilities which improve EMS system preparedness for mass casualty triage.


Lawyer or no lawyer?

If you are an EMS provider or an EMT or Paramedic who received a “Notice of Violation” letter (NOV) from DSHS proposing a disciplinary action and you followed up with a request for an informal conference and/or appeal hearing at the State Office of Administrative Hearings (SOAH), you may be wondering: “Am I required to bring a lawyer?”

Although a lawyer is not required, you may bring one to either the informal conference or to an appeal hearing at SOAH. You should probably consult with a lawyer before making that decision. If a lawyer will be coming with you, please have him/her provide the department’s enforcement unit with a formal letter of representation.
