News & Updates

- On July 12, 2021, the FDA announced a new warning for the Johnson & Johnson/Janssen COVID-19 vaccine. - On July 8, 2021, the CDC and the FDA jointly released a statement as it relates to booster dose. To review the full communication, please visit the HHS.gov webpage [here](#).
- The Moderna COVID-19 Vaccine 10-dose/100-dose trays have been phased out.
- The CDC will no longer be sending out dry ice for the Pfizer COVID-19 Vaccine.
- If you are in possession of a thermal shipper and are no longer utilizing it, ship it back to Pfizer ASAP.
- Providers cannot order additional ancillary supplies; they will need to use their own supply.
- On July 16, 2021, SOC TDEM/TMD will no longer be supporting the Data Entry Center.
- COVID-19 vaccines and other vaccines may now be administered without regard to timing.
