Region 8 Activities

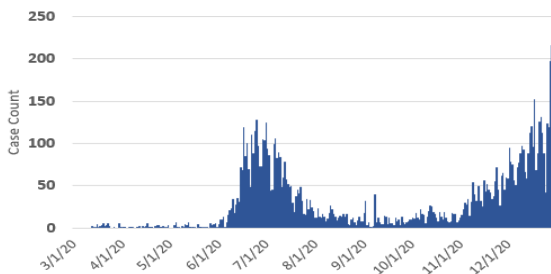
- Respond to COVID-19 pandemic by monitoring cases, tracing contacts and educating the community

Immunizations

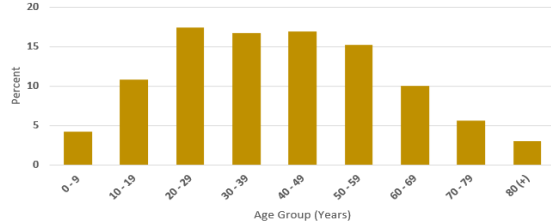
- The percent of school students with a conscientious exemption from immunizations filed at the school district level in Guadalupe County is 1.86% up from 1.04% in 2019

Daily COVID-19 Case Count¹

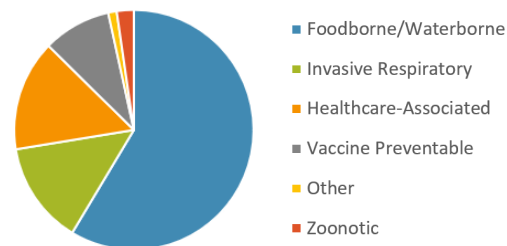


Age Distribution of COVID-19 Cases

2020 Public Health by the Numbers

- 5,751 confirmed cases of COVID-19
- 34.47 COVID-19 incidence (Incidence is calculated using confirmed case counts reported on the DSHS dashboard; calculated per 1,000 population)
 - 14 retail food inspections
 - 14 school cafeterias inspected
 - < 5 cases of tuberculosis
- 168 clients received case management services through the Specialized Health and Social Services program
- 2 rabies investigations conducted
- 3 rabies quarantine facilities inspected
- 167 dental evaluations for low-income children
- 162 fluoride treatments applied for low-income children
