- Reduce asthma morbidity
- Reduce serious mental retardation
- Reduce outbreaks of waterborne diseases and chemical poisoning
- Reduce high blood lead levels
- Reduce exposure to air pollutants
- Increase home radon testing
- Reduce exposure to toxic agents
- Reduce exposure to solid waste
- Increase supply of safe drinking water
- Reduce health risks from surface water
- Increase home testing for lead-based paint
- Expand construction standards to minimize indoor radon levels
- Increase disclosure of lead and radon concentrations in homes
- Eliminate health risks from the National Priority List hazardous waste sites
- Establish programs for recyclable materials and household waste
- Establish plans to define and track sentinel diseases
- Reduce child exposure to tobacco smoke at home
