Accessing the Report

The Clients and Immunization Count by Organization report displays the number of clients that received a dose and the total number of doses administered by an organization in a specified period. This does not include historical immunizations entered by the organization.

To generate the Clients and Immunization Count by Organization report follow the steps below.

Navigate to <u>IAMOnline.hhs.state.us</u> and log in using your IAMOnline user credentials and password. Then select the ImmTrac2 application to log in.

Once logged into ImmTrac2, navigate to the Reports section, and click "modernized reports".

Select the Clients and Immunization Count by Organization link from the report list.



Clients and Immunization Count by Organization report displays the number of unique clients that received a dose and total number of doses administered by an organization in a specified time period.

Generate Report

On the dashboard page enter the Target Date Range using the MM/DD/YYYY format or use the calendar icon (up to 12 months) The date range is available for a roll of five years, meaning that the dates inserted should reach a max of five years.

On this page, click the "Refresh" tab to reload the page to facilitate the processing of the report until the Status states "COMPLETE". Once the status is "COMPLETE" select the hyperlink to view the report. The first line indicates the report is still processing, while the second line shows the report is complete and the report name is a hyperlink to access the report.

Report Dashboard

Once the hyperlink is selected, the report dashboard is opened, based on the filters and date parameters set when generating the report. The report can be viewed either for a Count of Clients or a Count of Immunizations as shown below. You can toggle between these views by selecting their respective tabs. The dashboard defaults to opening the Count of Clients view.

The dashboard consists of the following four sections:

Section One - Heading and View Selection

The heading consists of the type of report, the filter parameter set, and the date and time the report was generated. Beneath the parameters and dates are the view tabs: Count of Clients and Count of Immunization. The view that is displayed is highlighted. The report opens in the Count of Clients view, which is the default.

Section Two - Note and Org Code Dropdown

Below the heading is a notation of the report and how to use the Org Code dropdown. On the right side of the report below the view highlight is the "Org Code" dropdown section. Users can use this section to select the organization report that they prefer to view on the table and graph.

Section Three - Counts in a Table

The counts, either clients or immunizations, depending on whether you selected the "Count of Clients" tab or the "Count of Immunizations tab in the heading, are displayed a in a table format for all organizations selected for which a user is responsible.

Section Four - Counts in a Line Graph

The counts are also displayed as a line graph below the table. This section of the report displays the counts of clients or immunizations, depending on which was chosen, in a line graph. It reflects the total count of clients or immunizations for each month based on the parameter of dates inserted. Hovering the mouse over this graph on each reveals the count for that month.

When the mouse is hovered above the table on the far right, a "More Option" is revealed. Every option found under the "More Option" is related to the table. Users can choose to print only the table information from this option.

Select the preferred format, "Data with current Layout" or "Summarized data." Once selected, click on "Export" at the bottom of the page to download the data.

- If "Data with current layout" is chosen as the export format, the data is exported as an Excel spreadsheet.
- If "Summarized data" is chosen as the export format, the data is exported as a table in Excel with filters applied to the columns.

Note: The Summarized data export option is the only format option available for the Line graph count.

- Count of Clients and Immunization tables can be exported or downloaded in two formats: Data with Current Layout and Summarized Data
- Count of Client or Immunization Line Graph has only one available format option, which is the Summarized Data Format.
