Note: Human mortality from arboviral conditions is aggregated and reported monthly once documentation has been received and verified.



Figure 1. Texas Counties Reporting Arbovirus Activity, Week 29






Figure 3. Human Cases of West Nile Virus Reported in Texas, by MMWR Week of Onset, 2022-2024, Week 29 14 -12 Number of Reported Cases 2024 2023 2022  $\ \ \, _{\mathsf{W}} \, \, _{\mathsf{Q}} \, \, _{\mathsf{Q}}$ **MMWR Week of Onset**
