



The department continues the implementation of the Chapter 157 rules adopted on November 24, 2024.

CARE vs. Treatment

"Our patients are human beings worthy of dignity and compassion."

Today, I want to discuss a crucial aspect of prehospital care that sometimes gets overshadowed by our profession's fast pace: putting **CARE** back into healthcare.

As EMS professionals, we're educated to handle emergencies, deliver critical interventions, and provide life-saving treatments. However, not every patient we encounter needs an advanced procedure or medical intervention. What they do need, every time, is care. Care is more than medicine. It's compassion, empathy, and respect for the person in front of us. Whether a patient has a life-threatening condition or is simply experiencing distress, our presence and how we engage with them can make all the difference.

Sometimes, a hand on the shoulder, a calm voice, a blanket, or the reassurance that they're not alone is the most valuable "treatment" we can offer. When we prioritize care, we remind our patients that they are more than a diagnosis or a set of symptoms. Putting care back into prehospital healthcare means seeing beyond the injury or illness and focusing on the whole person. It means showing up with empathy and understanding, not just with equipment and skills. Because while our patients may not always need treatment, they will always need care.

Let's recommit to putting care at the heart of what we do.

A Friendly Reminder About EMS ID Badges

Professionalism is essential in all we do. It shapes how we present ourselves, interact with others, and provide care. Remember to wear your identification badges when interacting with the public and treating patients. Looking professional is a requirement of the Texas Administrative Code.

TAC 157.11 (n)

Responsibilities of EMS Provider (6) assuring that all personnel, when on an in-service vehicle or when on the scene of an emergency, are prominently identified by, at least, the last name and the first initial of the first name, the certification or license level and the EMS provider's name. A provider may utilize an alternative identification system in incident specific situations that pose a potential for danger if the individuals are identified by name.



Child Maltreatment Regional Project

In response to a concerning increase in child fatalities linked to non-accidental trauma, the Central Texas Regional Advisory Council (CENTEX RAC) initiated a task force to address this concern. Key members of the task force, including paramedics Byron Sedleck and Elizabeth Hicks, collaborated to produce valuable resources aimed at helping healthcare providers recognize signs of child maltreatment. These resources are specifically designed for healthcare professionals, highlighting critical indicators of potential abuse or neglect to facilitate early detection.

Understanding the urgency of early intervention, Hicks and Sedleck worked to design a prehospital version tailored for paramedics and first responders. This accessible tool equips them with essential knowledge to identify signs of child maltreatment while in the field. The resource features a list of history red flags, as well as physical exam and evaluation indicators. These indicators include unexplained injuries, inconsistent explanations regarding injuries, and neglect signs, such as malnutrition or poor personal hygiene.

In addition to identifying potential cases of abuse, the resource emphasizes the importance of thorough documentation, prompt reporting, and clear communication with receiving hospitals and child protective services. By fostering collaboration between prehospital providers and hospital staff, this initiative aims to build a stronger community response to child maltreatment.

W.H.A.L.E. Car Seat Program

The W.H.A.L.E. (We Have A Little Emergency) car seat program is a safety initiative designed to help first responders quickly identify and assist children involved in car accidents. The program recognizes the importance of providing crucial information about young passengers who might be too young to communicate in emergencies.

The W.H.A.L.E. kit includes a set of stickers and labels that are placed on a child's car seat and the car windows. The car seat label contains vital details such as the child's name, medical conditions, and emergency contacts. In a collision, first responders can immediately access these details, ensuring appropriate care for the child passenger if the driver is seriously injured.

The Interstate Commission for EMS Personnel Practice Invites Public Comments on Proposed Rules for EMS Compact

The EMS Compact is a state law that functions as both a contractual agreement between states and state law. The Compact facilitates the day-to-day movement of EMS personnel across state boundaries in the performance of their duties. It increases access to patient care, protects the public, and reduces administrative burden for EMS personnel and states.

All comments on the proposed rules must be received by 3:00 PM ET on February 14, 2025.

Submit Comments

Key highlights of the proposed rules include:

- Clarifications for **EMS License Endorsements**: Expanding recognition of advanced educational programs and specialized certifications.
- Enhanced Guidance on the National EMS Coordinated Database: Addressing data types, ownership, integration, and additional data protection measures.
- **Introduction of a Code of Conduct**: Establishing professional standards and ethical expectations for EMS clinicians operating under the EMS Compact in all 24 member states.

For CY2025, we will continue collecting records in the National EMS Information System (NEMSIS) 3.5.0 format. We have no plans to implement the NEMSIS 3.5.1 or 3.5.2 minor revisions. Our staff will begin to prepare for the NEMSIS 3.6.0 major revision in 2026.

Beginning February 1, 2025, EMSTR will go through an annual network security audit. If you receive an email from our program, please promptly confirm the access privileges/rights for the staff currently assigned to your EMS agency account. Governor's EMS and Trauma Advisory Council Welcomes New Members

GETAC comprises 19 members appointmented by the Governor. Each represents a specific area related to trauma and EMS as defined in Texas Health and Safety Code §773.012.

GETAC begins the new year with a fully seated council and welcomes three new members.

Mr. Donald "Donny" Booth is the CEO of Permian Regional Medical Center and is the Rural Trauma Facility representative on GETAC. He is a member of the American College of Healthcare Executives, Emergency Nurses Association, American Organization of Nurse Executives, Texas Organization for Nursing Leadership, Texas Nurses Association, and the Andrews Downtown Lions Club.

Chief Brian Petrilla is the Certified Paramedic representative on GETAC and currently serves as the assistant chief of EMS for Fort Bend County, overseeing the critical operations and management of emergency services. Mr. Petrilla spent 25 years with the City of Houston Fire Department as a firefighter/paramedic and aircraft rescue firefighter.

Mr. Rodney Tidwell is the EMS Volunteer representative on GETAC. He currently serves as a field paramedic for University Medical Center EMS in Lubbock and is the EMS Administrator for the Post-Garza County EMS. Mr. Tidwell is a former city council member for the City of Post and a former firefighter with the Post Volunteer Fire Department.

The EMS office receives daily phone calls and emails asking about application processing times. Application processing can take up to 30 days. It may take longer during certain times of the year such as holidays. Most applications are approved, or a deficiency notice is sent within 10 days of submission. If you have not received your license or a deficiency notice within 30 days, you should contact our office.

Here's how to get licensed as quickly as possible:

The licensing team is committed to helping you get your certification as fast as possible.

- Complete the process online by applying once you have your NREMT certification and on the same day as your fingerprint background check appointment.
- Always list @dshs.texas.gov and @partner. hhs.texas.gov in your safe sender list.
- Please use a laptop or desktop computer when applying.
- When submitting a payment, allow the system time to process your transaction before you leave or close the page.

Things to keep in mind:

- The online licensing system will accept your application once the payment is complete, or you identify yourself as a volunteer, veteran, military member, or spouse.
- Failure to respond to a deficiency notice causes delays for most applicants.
 Remember, check your spam/junk
- Applicants with a criminal background may now use the online system to request a prescreen evaluation before enrolling in an EMS course.
- EMS license certificates and wallet cards are available in the secure mailbox within your online account three days after approval.

Here's how to ensure your renewal is smooth:

Your renewal application will open six months before your license expires. The department does not send renewal notices, so please keep track of your expiration date. When applying, review your renewal options closely and ensure you have met the requirements before completing the process (view Texas Administrative Code 157.38). In most cases, the system will renew your license automatically. If you select volunteer, please upload a new verification with your application. If you have not received your certification or a deficiency notice within 30 days, you should contact our office.

Things to keep in mind:

- Incorrect account information is the biggest problem when renewing; keep your account information current.
- If you use an employer's email address, remember to update your account if you change employers.
- Please do not wait until the end of the month or days before your license expires to log into your account.

Texas Medical Board Adopts New Rules for Chapter 169

New rules have been adopted by the Texas Medical Board and went into effect January 9, 2025, for Chapter 169 of the Texas Administrative Code, regarding EMS medical directors. The rules focus on delegation of patient care and physician oversight and replaces Chapter 197.

Key Highlights:

- **§169.10**, Definitions, explains the resources for definitions of words and terms used in Subchapter C of new Chapter 169, as applied to physician supervision of emergency medical service (EMS) personnel.
- **§169.11**, Medical Supervision, explains the statutory authority physicians providing medical control and medical supervision of EMS providers must adhere to.
- §169.12, Medical Director Qualifications, explains the requirements for a physician to be a medical director of EMS services.
- **§169.13**, Medical Director Responsibilities, explains the responsibilities of a physician acting as medical director of EMS services.
- §169.14, Limits on Off-Line Medical Control, explains the limit on the number of EMS providers an offline medical director may supervise.
- §169.15, Other Physician Presence at Medical Emergency, explains how care should be provided by another physician, other than an EMS medical director, at the scene of an emergency.

These changes do not affect the authority given under Health and Safety Code 773 and the Texas Administrative Code Chapter 157.

89 Session Update

The legislators were able to pre-file bills since mid-November, and as of this date, the EMS Trauma System Section has reviewed 23 bills that could have an impact on our EMS and trauma system. The Texas Ambulance Association and the Texas EMS Alliance is also reviewing bills to educate legislators.

Chapter 157.11 Amendments

The approved amendments include requirements concerning the transport of dialysis patients during a declared disaster, a correction to insurance liability limits, and clarification on EMS triage responsibilities. The effective date of these amendments is March 06, 2025.

Transporting Dialysis Patients during Disaster

Emergency medical services (EMS) providers must have a plan for transporting dialysis patients directly to an outpatient end-stage renal disease facility during a declared disaster if the patient's normal and alternative modes of transportation cannot be used. The amendment also permits the EMS provider's plan to prioritize transporting a patient suffering from an acute emergency condition over transporting a dialysis patient.

Insurance Liability Limits

A unit of local government under this chapter is limited to money damages at a maximum amount of \$100,000 for each person, \$300,000 for each single occurrence of bodily injury or death, and \$100,000 for each single occurrence for damage to or destruction of property as described in Texas Civil Practice and Remedies Code §101.023(d).

EMS Triage

The amendment clarifies that an EMS provider must participate in the Regional Advisory Council (RAC) triage plan or carry 25 triage tags on each ambulance, aligning with current practice throughout Texas and the nation.

Additional Changes

There is a change to the rules regarding a reference to the Texas Health and Safety Code §773.05711 requirements for a letter of credit when renewing or obtaining an EMS provider's license. This will take effect on March 10, 2025.



Regional Advisory Council Funding

Stakeholders have requested a step-by-step overview of the RAC funding allotment calculations and the RAC EMS pass-through funding. This process begins with the EMS providers and the designated trauma facilities submitting data to the State Registries to ensure the defined year's data is entered before the year's closing date.

An example of the year-end closeout is the EMS emergency transports January 1, 2024, through December 31, 2024; submissions to the state registry will close at the end of April 2025. This year-end closeout is the same for EMS providers and trauma facility submissions.

Trauma Uncompensated Care Funding

The 2025 trauma uncompensated care application is available. All completed applications (Part A, B, and C) must be submitted to the department by **April 20, 2025**, for consideration of funding. The department will hold conference calls in early February to answer questions regarding the completion of the application.

Stakeholders have requested a step-by-step overview of the funding calculations for the trauma uncompensated care application. This is in development and will be shared once completed.



Texas Alliance for Innovation on Maternal Health (TexasAIM)

In 2024, the Texas Alliance for Innovation on Maternal Health (TexasAIM) and Maternal Designation collaborated to provide maternal surveyors with training for Texas AIM bundle implementation. Maternal surveyors were also invited to attend the TexasAIM Summit held in December.

Facility Calls

Virtual meetings are held monthly for all designated facilities to provide support to program leadership and encourage statewide collaboration and problem solving for the improvement of trauma, stroke, maternal, and neonatal care throughout the state.

Performance Measures

The performance measures for completing the designation process are 30 days for non-continuous designations and 60 days for contingent designations. The process starts with receiving a complete application, including the fee, and ends with the commissioner approving the designation letter and certificate being sent to the facility.

Status Numbers:

Trauma 39 days non-contingent, 35 days contingent

Stroke 17 days

Maternal 38 days non-contingent, 67 days contingent

Neonatal 38 days non-contingent, 48 days contingent



The Medical Advisory Board (MAB) was established in 1970. It serves to advise the Texas Department of Public Safety (DPS) on the licensing of drivers having potential medical limitations that might adversely affect their driving capabilities. See Chapter 12 of the Texas Health and Safety Code, Section 12.092 – 12.098. The goal is to allow all who can drive safely to do so and to reduce the number and severity of motor vehicle crashes in Texas. The Texas Transportation Code, Chapter 521, charges DPS with the responsibility of determining if applicants or licensees can safely drive when a medical condition exists that has the potential to affect their ability to drive. MAB reviews these referrals from DPS for driver's licenses, licenses to carry, and school bus waivers.

Annually, MAB receives an average of 5000 referrals from DPS to review drivers license cases.

Rules

The department and MAB have provided recommendations to repeal and provide new language to Sections 1.151 and 1.152 to comply with changes to:

- Texas Health and Safety Code Sections 12.091 12.098
- Texas Transportation Code Section 521.294, and
- Texas Administrative Code Section 15.58.

This rule packet, 24R080, is scheduled for adoption in February of 2025. This reflects updates to MAB membership, operations, requirements, medical packet content, and confidentiality provisions.

The Texas Department of State Health Services (DSHS) and the Medical Advisory Board (MAB) members recognize Dr. Leanne Burnett, a neurologist from the Houston area, for her exemplary leadership and commitment to MAB. Dr. Burnett chaired the MAB Performance Improvement Committee and produced many innovations that updated MAB forms, practices, and organizational structure. She was instrumental in developing MAB bylaws that created an effective leadership process and led collaborative tasks with DPS that streamlined and improved the DPS referral review and medical opinions rendered. Dr. Burnett was elected the first official Chair of MAB.

Due to unplanned events, Dr. Burnett resigned from MAB in 2024, but her leadership goals and legacy of innovations continue.


