Timeline of Title Changes:

- In 1954, the title of *State Health Officer of Texas* was changed to *Texas Commissioner of Health*.
- In 2004, the title of *Texas Commissioner of Health* was changed to *Commissioner, Texas Department of State Health Services*.

State Health Officer of Texas (1879-1954)

NOTE: Title of ***State Health Officer of Texas*** was used from 1879–1954.

A legislative act creating the position of a State Health Officer of Texas to serve a 2-year term was passed in 1879.

Governor Charles A. Culberson appointed Blunt as State Health Officer of Texas to fill the unexpired term of Dr. R. M. Swearingen, who died on August 9, 1898.

- In September 2004, the Texas Department of Health was merged into the Texas Department of State Health Services.
- Dr. Sanchez was chosen to lead the new agency. The Texas Department of State Health Services combines the former Texas Department of Health, the Texas Commission on Alcohol and Drug Abuse, Texas Health Care Information Council, and the mental health component of the Texas Department of Mental Health and Mental Retardation.
