Program decision to add a requirement for an adult staff member currently certified in AED, CPR, and first-aid to accompany campers on off-site field trips in the current rule revision project.

phone number. If you have completed the Public Comment Registration form, you will receive an email the day before the meeting with instructions for providing virtual public comment. Public comment is limited to three minutes. Each speaker providing oral public comments virtually must ensure their face is visible and their voice audible to the other participants while they are speaking. Each speaker must state their name and, on whose behalf, if they are speaking for anyone. If you pre-register to speak and wish to provide a handout before the meeting, please submit an electronic copy in accessible PDF format that will be distributed by DSHS staff to Youth Camp Advisory Committee members and State staff. Handouts are limited to two pages (paper size: 8.5" by 11", one side only). Handouts must be emailed to jeffrey.mantia@dshs.texas.gov immediately after pre-registering, but no later than 5:00 p.m., Monday, March 24, 2025, and include the name of the person who will be commenting. Do not include health or other confidential information in your comments or handouts. Staff will not read handouts aloud during the meeting, but handouts will be provided to Youth Camp Advisory Committee members and State staff. It is not permissible for public speakers to interject or ask questions to Youth Camp Advisory Committee members during the rest of the meeting.

2.
