The committee also discussed proposed new joint rules with the State Committee of Examiners in the Fitting and Dispensing of Hearing Instruments, proposed in Chapter 741 as Subchapter P. Joint Rules for Fitting and Dispensing of Hearing Instruments by Telepractice, §§ 741.231-741.233.
