SUBJECT: Update to Contract with Spacenet Satellite Provider to End December 11, 2013

The following updates information provided in Memo #13-090 dated September 5, 2013 regarding the Spacenet Satellite discontinuation.

Sites with Verizon connections currently.

As you are aware, the WIC State Office is in the process of closing down VSAT (satellite) connectivity to the clinics because the contract with Spacenet, the satellite provider, ends December 11, 2013. Already, VSAT has been replaced in most sites with Verizon connectivity, either through a T1 line or an EVDO (wireless) box. The sites currently using Verizon connectivity to transmit data will continue to do so. However, after December 11, 2013, these sites will no longer have VSAT as a backup option.

Spacenet will be visiting clinics in 2014 to remove the satellite dishes currently installed. No removal is required by your agency. Spacenet will coordinate with your clinic for a date and time to remove the satellite equipment.

Permanent sites without Verizon connection currently.

Many current sites (both permanent and satellite) with VSAT that **do not** currently have a Verizon connection will continue to have VSAT until June 11, 2014. A different provider, AT&T, has been hired to install T1 lines at most of these sites. Installation should begin during the month of December 2013. See attached list titled *WIC Permanent Sites for VSAT Extension*.

Laptop Sites without Verizon connection currently.

The laptop sites that currently have a VSAT connection fall into two categories:

Group A: Some sites covered by laptop that currently have a VSAT connection will continue to have VSAT until June 11, 2014. These sites will have some form of connectivity after this time. See the Group A list below.

Group B: Some sites covered by laptop that currently have a VSAT connection will continue to be covered by the laptop, but will require docking back at the assigned permanent site because **this group will not have VSAT after December 11, 2013**. See the Group B list below.
